About the Seminar: The WZ Seminar on Gang Investigations was developed to increase the knowledge and enhance the skills of law enforcement professionals who deal with members of criminal street gangs. This course addresses the evolving connection between gangsterism and terrorism, details current and future trends in gang activity, and explains the process of qualifying as a gang expert.

The instructor, John J. Guzman, CFI[®] developed this course based on his career with the Chicago Police Department. John was assigned for twenty-one years to the Gang Investigation Section and worked under the command of Philip J. Cline, who later became the **Superintendent of the Chicago Police Department**.
