**INSTRUCTIONS FOR COMPLETING QUARTERLY BUSINESS LICENSE  
RETURN HOURLY CAR RENTALS FORM RD-207**

- For changes to name, address or FEIN/SSN complete Form RD-100. For questions contact the Revenue Division at [revenue@kcmo.org](mailto:revenue@kcmo.org) or (816) 513-1120.
- **Definition.**  
Every individual person or business entity as described in Section 40-61 of the Kansas City Code of Ordinances, engaged in the business of renting, leasing, or letting passenger vehicles for compensation shall pay to the City a license fee of \$0.17 per hour or \$0.50 for the total period of rental, whichever is greater.
- **Penalty.** There are two penalties:
  1. Penalty of 5% per month for failure to file a return timely (maximum penalty 25%)
  2. Penalty of 5% for failure to pay the amount due
- **Interest:** Any remaining unpaid tax after the due date is delinquent and shall be assessed interest at the rate of 3% annually. Statutory interest rate based on RSMo Section 32.065.
- **Quarterly Filing Schedule**

**Instructions for completing RD-207**

- Line 1.** Enter number of rentals of a passenger vehicle less than or equal to 2 hours during the quarter
- Line 2.** Enter amount due (Line 1 times \$0.50)
- Line 3.** Enter number of rental hours of a passenger vehicle rented for more than 2 hours during the quarter
- Line 4.** Enter amount due (Line 3 times \$0.17)
- Line 5.** Enter amount due (Sum of Lines 2 and 4)
- Line 6a.** For failure to file return timely enter penalty of 5% of Line 5 per month (maximum penalty 25%)
- Line 6b.** For failure to pay amount due enter amount of penalty due (Line 5 times 5%)
- Line 7.** Enter interest due (0.25% of Line 5 per month). Statutory interest rate based on RSMo Section 32.065
- Line 8.** Enter amount of previous credit or prior payments
- Line 9.** Enter total amount due (Sum of Lines 5, 6a, 6b, 7 minus Line 8)
- Line 10.** Enter amount paid
- Line 11.** Enter "X" if this amends a previously submitted return for the same period
- Line 12.** Enter date business closed or no longer conducting business in Kansas City, Missouri, if applicable
